## Meeting notes

#### Partner roles

It was identified that there was an overlap between the work of Chiltern Rangers and that of BBOWT. For the purposes of this project, it would be easier to define the role of Chiltern Rangers to provide projects within the community working with community groups and parishes and for BBOWT to focus around putting together an information pack. Should the Community response exceed the capacity of Chiltern Rangers then BBOWT could assist.

## Wildlife pack

Parish Councils and schools could apply for a quantity of the packs which residents could collect from them.

The packs would consider of an A4 colourful factsheet with ideas on how to encourage wildlife and promote green spaces as well give a step-by-step guide to tackle a simple project. BBOWT Marketing Team to pool together some existing resources and provide costs for putting together the pack. Costs would enable the concept to be replicated across other interested Community Boards.

- Residents would be geared towards families and making a difference in any space however small.
- Parishes could take part if they had land or grass verges, they wanted to attract wildlife.
- Community Groups to initiate local projects within the community.
- The ReLEAF Project could also include an item on suitable small trees to plant

#### **Funding**

Paul Irwin advised that AVDC had given some funds to Heart of Bucks for their Green Futures fund to work with Chiltern Rangers on projects in the Vale. This project ceased due to Covid. Paul has established that £18,500 is left in that fund, which the Community Board could use to fund Chiltern Rangers providing workshops out in the community. BC to ringfence funding for CB project. Chiltern Rangers costs were £360 per day plus VAT.

Parish Councils would be asked to contribute towards funding to enable Chiltern Rangers to work with more partners.

Parishes and Schools could apply for either of the following Heart of Bucks Funds to contribute funding to a project. If any Working Group members knew of organisations that might benefit from this to let Chiltern Rangers know.

- Green Schools Fund open to all schools in Aylesbury Vale area Funding up to 1,500. Deadline 9<sup>th</sup> December 2020
- Green Community Fund up to £2,500. Deadline 9<sup>th</sup> December 2020

It was noted that green initiatives can include education such around behavioural changes such as littering.

Chiltern Rangers could assist supporting an organisation to complete an application for tree planting.

## Competition

A competition would be held with categories for residents, parishes, schools and community groups.

Paul requested Quainton Windmill cost out the provision of 100 bird and bug boxes (50 of each) which could be given as prizes. He would be ideally looking at a budget of around £1000.

Before and after photos would be requested to demonstrate the difference made.

Family Information Service – would support the project and promote through their centres.

#### Timescale

• The Working Group would look to launch the project in January 2021.

• Competition prizes of bird and bug boxes to be ready by March-April 2020.

#### ReLEAF Project Releaf@zeroch.org

Kirstan Shaw gave a presentation on the Haddenham ReLEAF Project – an initiative by <u>Zero-Carbon Haddenham</u> to double tree cover in the Haddenham Parish by 2030.

She explained that trees absorb and store carbon and reduce the effects of wind damage. The project, as well as planting trees, carried out surveys and developed processes to help with planting including the development of associated risk assessments and securing public Liability Insurance. Tree planting was piloted on different types of land and now the project has requested more PC owned land to plant additional trees as well as supporting a local farmer to plant trees. They identified a gap in understanding the practicalities of tree planting and how to go about it so have been working with BC Highways Team to set up a Tree Planting Task and Finish Group to develop and disseminate appropriate guidance to support community tree planting projects across Bucks. Maintenance of trees is down to the landowner. If wanting to plant trees on the Highway a group must first apply to BC for a licence which costs £100 and involves conducting a survey above and below ground to determine any hazards and what species of tree would be most suitable for that location.
